- (c) Students who have previously completed the New York State Basic Course for Police certified by the New York State Department of Criminal Justice may apply to the Dean of Business and Professional Programs for a prior learning assessment of their specific certification. This will require the student to submit their Official New York State Department of Criminal Justice Services Transcript.
 - 1) If the student's basic course completion is prior to 2024 special attention will be paid to which version of the New York State Curriculum the student completed. If the student has additional course work with the Department of Criminal Justice or equivalent professional experience, certifications or licenses the student may meet the minimum requirement to be considered for awarding this certificate. (An outside subject matter expert may be considered to accomplish this assessment).
